MEETING: Special Called Meetings - 13 May 2024

TITLE:

Consider a Resolution Canvassing and Declaring the results of the May 4, 2024, General and Special Election for Mayor and Councilmembers for Districts two (2), four (4), and five (5).

BACKGROUND/HISTORY:

The Joint Election Agreement and Election Services Contract between the City of Duncanville, Dallas County, and other jurisdictions in Dallas, Collin, and Denton Counties, was to conduct a Joint Election held on Saturday, May 4, 2024; and provides that the Dallas County Elections Administrator is responsible for the preparation of the unofficial canvass report; and will provide by email a copy of the unofficial canvass to each Participating Political Subdivision after all returns, provisional ballots, and late overseas ballots, have been tabulated.

Per the Dallas County Elections Department, canvass may not be conducted until all Election Day (ED)

Provisional and Federal Postcard Application (FPCA) (Overseas) ballots have been counted. The last day to receive FPCA Ballots is Friday, May 10, 2024. The Ballot Board, by the election code, has until Monday, May 13th to count both Provisional and FPCA ballots and then provide them to Central Count

for counting. The last day to canvass for the May 4, 2024 General Election is Wednesday, May 15, 2024.

As of today, May 6, 2024 the City Secretary has not received the final voting results. Once received the City Secretary will upload the new Resolution to reflect the final voting totals for Canvassing the May 4, 2024 General Election results.

RESOLUTION NO. 2024-267

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DUNCANVILLE, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE MAY 4, 2024, JOINT AND GENERAL ELECTION FOR MAYOR AND COUNCILMEMBERS IN DISTRICTS TWO (2) AND FOUR (4) AND SPECIAL ELECTION FOR COUNCILMEMBER DISTRICT FIVE (5); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is hereby found and determined that notices of a general and special election were duly given in the form, manner and time required by law, and said elections were in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings calling and governing the holding of such elections; and

WHEREAS, it is imperative to consider the returns of the general election held on May 4, 2024, for the purpose of electing the hereinafter named officials before the qualified voters of the City; and

WHEREAS, the returns of the general election have been duly and legally made and submitted to the City Council for canvassing and a tabulation of the returns for the polling places and for early voting, as canvassed and tabulated by this governing body.

NOW, THEREFORE, be it resolved by the City Council of the City of Duncanville, Texas, after examining said returns and opening and canvassing the votes of said election, that the results of said general election are as follows:

SECTION 1. That the following number of votes were cast for the following named candidates for the office of Mayor to wit:

It appears that Greg Contreras received a majority of all votes cast for the office of Mayor, Greg Contreras is hereby declared to be elected to serve a two (2) year term after qualifying and taking the oath of office.

SECTION 2. That the following number of votes were cast for the following named candidate for the office of Councilmember District 2, to wit:

It appears that Don McBurnett received a majority of all votes cast for the office of Councilmember District 2, Don McBurnett is hereby declared to be elected to serve a two (2) year term after qualifying and taking the oath of office.

SECTION 3. That the following number of votes were cast for the following named candidate for the office of Councilmember District 4, to wit:

It appears that Karen Cherry-Brown, being unopposed and otherwise having received a majority of all votes for Councilmember District 4, Karen Cherry-Brown is hereby declared to be elected to serve a two (2) year term after qualifying and taking the oath of office.

SECTION 4. That the following number of votes were cast for the following named candidate for the office of Councilmember District 5, to wit:

It appears that Kyle Pennebaker received a majority of all votes cast for the office of Councilmember District 5; Kyle Pennebaker is hereby declared to be elected to serve the remainder of the unexpired term (one year) after qualifying and taking the oath of office.

SECTION 5. This Resolution declaring the results of the municipal elections shall become effective immediately after its passage.

IT IS ORDERED that this canvass and declaration of results of said election shall be entered in the Minutes of the City Council and that officers for the Mayor, District 2, District 4, and District 5, after being qualified and having taken the oath, shall serve during the term commencing May 21, 2024, and thereafter until a successor is duly elected and qualified.
